

AN ORDINANCE APPROPRIATING THE AMOUNT OF P3,069,528.70, P901,583.50 OF WHICH IS TO BE MADE AVAILABLE FOR THE PURCHASE OF TEXTBOOKS TO BE LOANED FREE OF CHARGE TO STUDENTS IN THE CITY PUBLIC SCHOOLS, AND P2,167,945.20 FOR THE PURCHASE OF SUPPLEMENTARY READERS AND OTHER INSTRUCTIONAL MATERIALS AND TEACHING AIDS AND DEVICES, UNDER CERTAIN CONDITIONS.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P3,069,528.70, or so much thereof as may be necessary, is hereby appropriated out of any fund (P1,582,451.49 from the balance of P5,000,000.00 originally earmarked for textbooks and P999,263.50 from the unappropriated account) existing in the City Treasury not otherwise appropriated to be made available for the following purposes:

1. For the purchase of additional textbooks to be loaned free of charge to students in the city public schools P 901,583.50
 2. For the purchase of supplementary readers and other instructional materials 2,070,265.20
 3. For the acquisition of teaching aids and devices, etc. 97,680.00
- Total - P3,069,528.70

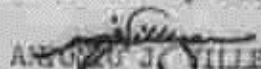
SEC. 2. The Superintendent of City Schools is hereby authorized to purchase the herein textbooks, supplementary readers and other instructional materials and teaching aids and devices, not to exceed the estimated prices as per itemized lists submitted by him in two separate communications dated July 10, 1962 and August 29, 1962, respectively, and approved by the Municipal Board of the City of Manila; PROVIDED, HOWEVER, That the said Superintendent of City Schools shall, one year from the date of the approval of this Ordinance, submit to the Municipal Board a list of all textbooks, supplementary readers and other instructional materials and teaching aids and devices purchased, with the corresponding prices thereof; PROVIDED, FURTHER, That whatever amount is not spent for the purpose herein stated shall, one year from the date of the approval also of this Ordinance, revert to the general funds of the City.

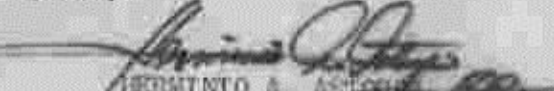
SEC. 3. This Ordinance shall take effect upon its approval.
