ORDINANCE NO. 8998

AN ORDINANCE AMENDING SECTIONS 2 AND 4, OF ORDINANCE NO. 8109, ENTITLED: "AN ORDINANCE PROVIDING FOR THE USE OF WHEEL CLAMPS TO IMMOBILIZE ILLEGALLY PARKED VEHICLES, IMPOSING PENALTIES FOR VIOLATIONS THEREOF, AND FOR OTHER PURPOSES"

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2 of Ordinance No. 8109 is hereby amended and shall now read as follows:

"SEC. 2. The wheel clamp or tire lock is a yellow metal gadget or immobilizing device duly registered, authorized and bearing the seal of the City of Manila that is placed on the left or right portion of the front tires of the vehicle, including motorcycles, cars, container vans, trucks, trailers and other multi-wheeled vehicles, and shall be installed by the authorized personnel of the Manila Traffic and Parking Bureau (MTPB).

Before installation of the wheel clamp, the authorized MTPB personnel shall observe ten (10) minutes grace period to afford the vehicle owner the opportunity to move their vehicle and avoid apprehension.

The power to designate further clamping zones shall lie before the City Council of Manila"

SEC. 2. Section 4 of Ordinance No. 8109 is hereby amended and shall now read as follows:

"SEC. 4. The clamping operation of Manila Traffic and Parking Bureau (MTPB) shall be until 5:00 pm, likewise the redeeming hour will be extended until 8:00 pm, within which they pay the amount of the fine prescribed in Section 3 hereof."

SEC. 3. Effectivity Clause. - This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on October 12, 2023.
