PROCEDURE OF THE SANGGUNIANG PANLUNGSOD NG MAYNILA, AS AMENDED,  
AND FOR OTHER PURPOSES**

WHEREAS, the Sangguniang Panlungsod ng Maynila adopted its Internal Rules of Procedure on July 4, 2022 by virtue of Resolution No. 112, Series of 2022, pursuant to and in accordance with the provisions of Sec. 50, Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Rule XXVII of the Internal Rules of Procedure states that the same may be amended or revised by two-thirds (2/3) votes of all the members of the Sanggunian, duly elected and qualified, but only after the lapse of six (6) months from the date of its adoption.

WHEREAS, in the maintenance of good order in Sanggunian deliberations, the Body deems imperative to amend its existing Internal Rules of Procedure in the interest of effective legislation;

WHEREAS, Rule XII, Section 32, in the Internal Rules of Procedure is hereby amended to be read as:


"REGULAR SESSIONS – The regular session of the Sanggunian shall be held every Tuesdays at 2 o'clock (2 p.m.) in the afternoon and Thursdays at ten o'clock (10 a.m.) in the morning of each week at its session hall located at the Manila City Hall or at such time and place as may be determined by the majority of all the Members of the Sanggunian in the immediately preceding session. Provided, however, that...xxx":

RESOLVED, by the City Council of Manila to amend, as it hereby amends Rule XII, Section 32 of the Internal Rules of Procedure of the Sangguniang Panlungsod ng Maynila, as amended, and for other purposes; and be it FURTHER
