WHEREAS, the 2023 Barangay and Sangguniang Kabataan Elections were simultaneously held on 30 October 2023 where the elected ones will assume office at 12:00 noon of 30 November 2023;

WHEREAS, the City Government of Manila, Department of Interior and Local Government, National Youth Commission, Manila Youth Development and Welfare Bureau, and Sangguniang Kabataan Federation released a joint memorandum to require all elected Sangguniang Kabataan Chairperson to attend a mandatory training before they can assume office;

WHEREAS, the joint memorandum is pursuant to Revised IRR, Rule V, Section 31 of Republic Act No. 11768 which provides that "the SK Officials and Members of LYDC are required to undergo the Mandatory Training Program before they can assume office";


WHEREAS, the goal of SK Mandatory Training is to instill the principles of nationalism, patriotism and honor as Filipinos while also highlighting the role of Sangguniang Kabataan in nation-building;

WHEREAS, Section 27 under Chapter V of Republic Act No. 10742, states that "For the purpose of emphasizing the role of the youth in nation-building and molding them to become better citizens with the values of patriotism, nationalism and honor as a Filipino, any Sangguniang Kabataan official, whether elected or appointed, or any member of the LYDC must undergo the mandatory training programs before he or she can assume office. During their incumbency, they must attend the continuing training programs to be undertaken by the Commission in coordination with the DILG. Deliberate failure to attend the said training programs shall constitute sufficient ground to disqualify said Sangguniang Kabataan official or LYDC member or subject them to disciplinary actions": NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to urge, as it hereby urges all elected Sangguniang Kabataan chairpersons in the recently concluded 2023 Barangay and Sangguniang Kabataan Elections (BSKE) in the City of Manila to attend the mandatory training on 10 November 2023 at 12:30 pm to 8:30 pm at the Century Seafood Restaurant, Malate, Manila; and be it FURTHER


RESOLVED, that a copy of this Resolution be furnished the Manila Public Information Office for posting at their social media platforms and all barangays within the jurisdiction of the City of Manila.
