WHEREAS, on November 10, 2023 at around 5:30 AM, a fire broke out and razed a portion of Arellano St. corner Gonzalo St., within the territorial jurisdiction of Barangay 732, Zone 80, District V, rendering more or less, sixty-nine (69) families affected;

WHEREAS, the Sangguniang Barangay, through Punong Barangay Roberto Reyes, requested the City Council that their barangay be declared a calamity area so that their calamity fund be released to alleviate the needs of the victims: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to declare, as it hereby declares that portion of Barangay 732, Zone 80, in the Fifth District, which was razed by fire on November 10, 2023, A CALAMITY AREA; and be it FURTHER

RESOLVED, that a copy of this Resolution be furnished the above-mentioned barangay for legislative support purposes to facilitate the immediate release of barangay calamity fund thereof.
