WHEREAS, the Pamantasan ng Lungsod ng Maynila (PLM) is a premier learning institution in the City of Manila located inside the historic walled city, in Intramuros area, that provides tertiary-level education;

WHEREAS, the Physicians Licensure Examination was administered by the Board of Medicine in October 2023, in various testing centers around the country;

WHEREAS, PLM ranked second in the top performing schools in the said examination where it registered a 97.32% passing rate;



RESOLVED, that a copy of this Resolution be furnished the Pamantasan ng Lungsod ng Maynila (PLM).


