WHEREAS, the SAMAR G. TUAZON TODA INC., with office address at 1005 Samar Street, Barangay 564, Sampaloc, Manila, a duly registered organization with the Securities and Exchange Commission (SEC), is seeking accreditation as registered People's Organization (PO);

WHEREAS, SAMAR G. TUAZON TODA INC., aims to contribute in the upliftment and development of the quality of life, not only of the members, but also of the less fortunate members of the society, as well as launching various humanitarian and livelihood programs that are designed to promote self-reliance and economic independence;

WHEREAS, the Association's purposes are as follows:

- 1. To establish an organization that will support the tricycle operators and drivers plying the route of Samar G. Tuazon, Sampaloc, Manila area;

WHEREAS, after careful study and perusal of all the requirements submitted, it was established that it has all the qualifications to be accredited as a People's Organization of Manila: NOW, THEREFORE, be it
