WHEREAS, the ASSOCIATES OF THE URBAN POOR, INC., with office address at Center for Cohesion and Resilience Building (CCR), Kabalikat sa Kaunlaran ng Baseco, Inc Block 1 Dubai Housing (Playground), Barangay 649, Zone 68, Bagong Lupa (BASECO) Port Area, Manila, a duly registered organization with the Securities and Exchange Commission (SEC), is seeking accreditation as registered Non-Governmental Organization (NGO);

WHEREAS, ASSOCIATES OF THE URBAN POOR, INC., aims to contribute in the upliftment and development of the quality of life, not only of the members, but also of the less fortunate members of the society, as well as launching various humanitarian and livelihood programs that are designed to promote self-reliance and economic independence;

WHEREAS, the Association's purposes are as follows:

- 1. To initiate social and economic program to benefit the urban poor of the Philippines;
- 2. To engage in research on the problems of the urban poor and to publicize the results; and
- 3. To cooperate with the government and all agencies working for the betterment of the urban poor;

WHEREAS, the same organization submitted the accomplished requisites and supporting documents for purposes of accreditation;

WHEREAS, after careful study and perusal of all the requirements submitted, it was established that it has all the qualifications to be accredited as a Non-Governmental Organization of Manila: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the accreditation of Associates of the Urban Poor, Inc., to become an accredited Non-Governmental Organization of the City of Manila; and be it FURTHER

RESOLVED, that a corresponding Certificate of Accreditation be attached hereto and be issued to the said association; and be it FINALLY

RESOLVED, that copies of this Resolution be furnished the Department of the Interior and Local Government (DILG) and the NGO concerned.
