RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS, REPRESENTING THE CITY GOVERNMENT OF MANILA, TO ENTER INTO A DATA SHARING AGREEMENT WITH THE HEALTH SECURITY PARTNERS, IN RELATION TO THE SUBCONTRACT AGREEMENT NO. HSPO-CDC-OSSAM AND HSP CDC-OSSAM 2024-001, WHEREIN THE OSPITAL NG SAMPALOC SHALL PERMIT ACCESS TO RECORDS AND FINANCIAL STATEMENTS, AND ENSURE AND ACCESS TO HEALTH SECURITY PARTNERS OR ITS DESIGNEE ALL NECESSARY SITES, DOCUMENTATION, INDIVIDUALS, AND INFORMATION

WHEREAS, on October 26, 2023, the City Council of Manila was in receipt of a letter from Atty. Marlon M. Lacson, Secretary to the Mayor, requesting for adoption of a resolution granting the Local Chief Executive authority to enter into a Data Sharing Agreement. The letter comes up with a draft instrument;

WHEREAS, on November 14, 2023, the City Council passed Resolution No. 552, Series of 2023, entitled: "Resolution authorizing the Honorable, City Mayor Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, representing the City Government of Manila, to enter into a Subcontract Agreement between the City of Manila and Health Security Partners/US Centers for Disease Control and Prevention in the Global Action in Healthcare Network", a Washington D.C., USA-based non-profit organization tasked to improve Health Security around the World and the Ospital ng Sampaloc (OSSAM), a primary city government hospital;

WHEREAS, the Ospital ng Sampaloc shall permit access to records, financial statements and may include personal information of the patients in the proposed agreement;

WHEREAS, pursuant to the Implementing Rules and Regulations (I.R.R.) of R.A. No. 10173, otherwise known as the "Data Privacy Act of 2012", there is a need to execute a Data Sharing Agreement between Ospital ng Sampaloc and Health Security Partners, which provides safeguards for data sharing, in accordance to the National Privacy Commission (NPG) Circular No. 2020-03;

WHEREAS, the letter-request, together with the proposed Data Sharing Agreement (DSA), was referred to the City Council for appropriate action;

WHEREAS, the instrument was presented to the open session of the Manila City Council which allowed to discuss and deliberate on the merits of the matter and after a few exchanges of views, the request was unanimously approved: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the Honorable, City Mayor Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, representing the City Government of Manila, to enter into a Data Sharing Agreement with the Health Security Partners, in relation to the Subcontract Agreement No. HSPO-CDC-OSSAM and HSP CDC-OSSAM 2024-001, wherein the Ospital ng Sampaloc shall permit access to records and financial statements, and ensure and access to Health Security Partners or its designee all necessary sites, documentation, individuals, and information.
