WHEREAS, DAMPA SASA NG PALAYAN INC., aims to contribute in the upliftment and development of the quality of life, not only of the members, but also of the less fortunate members of the society, as well as launching various humanitarian and livelihood programs that are designed to promote self-reliance and economic independence;

WHEREAS, the Association's purposes are as follows:

WHEREAS, the same organization submitted the accomplished requisites and supporting documents for purposes of accreditation;


