**RESOLUTION** CONDEMNING THE FALSE ENDORSEMENT OF OSTEOARTHRITIS TREATMENTS BY SUPPORTING THE DEPARTMENT OF HEALTH'S EFFORTS TO COMBAT MISLEADING HEALTH INFORMATION

WHEREAS, the Department of Health (DOH) has issued a public warning on November 14, 2023, regarding the misleading promotion of a supposed treatment for osteoarthritis, falsely using the name of Secretary Teodoro Herbosa;

WHEREAS, such deceptive practices not only mislead the public but also undermine the credibility of legitimate medical treatments and advices;

WHEREAS, the DOH has expressed intent to collaborate with the Food and Drug Administration (FDA) and other relevant government entities to investigate these fraudulent activities;

WHEREAS, it is essential for the public to rely on validated information from legitimate sources for their health and well-being, hence, the following steps should be undertaken to resolve the issue:

- Support the DOH in their efforts to investigate and take legal action against individuals or organizations responsible for spreading misleading health information;
- Encourage Manila residents to seek health information from legitimate and verified sources, and to be cautious of unverified medical claims, especially those found in unsolicited advertisements;
- Encourage relevant city health agencies to coordinate with the DOH and the FDA in monitoring and reporting any similar cases of misleading health information within Manila;
- Urge the city's public information office to initiate awareness campaigns, educating the public about the risks of unverified health treatments and the importance of consulting healthcare professionals: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to condemn, as it hereby condemns the false endorsement of osteoarthritis treatment by supporting the Department of Health's efforts to combat misleading health information.
