## RESOLUTION NO. 587 Series of 2023

RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF MANILA THROUGH THE HONORABLE MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE RED CROSS FOR THE PROVISION OF PERSONAL ACCIDENT INSURANCE FOR THE SPECIAL PROGRAM FOR EMPLOYMENT OF STUDENTS BENEFICIARIES OF THE CITY OF MANILA

WHEREAS, on November 22, 2023, the City Council of Manila was in receipt of a letter from Atty. Marlon M. Lacson, Secretary to the Mayor, requesting for adoption of a resolution granting authority to the Local Chief Executive to enter into a Memorandum of Agreement (MOA) concerning the provision of personal accident insurance coverage. The letter comes with a draft Memorandum of Agreement (MOA) which was forwarded for review to the City Legal Office;

WHEREAS, the City Legal Officer, upon review, has raised no objection to the execution of a new MOA, subject to amendments as stated, considering the certification issued by the City Budget Officer that there is sufficient funding for the Manila SPES Program for the current year;

WHEREAS, it was also emphasized that it found the implementation of the proposed MOA to be consistent with the power of the City Government of Manila under the General Welfare clause which is "to promote full employment among their residents" (Section 16, Republic Act No. 7160);

WHEREAS, considering that there will be substantial financial obligation on the part of the city as it is obligated to pay the premium in the amount of Sixty Pesos (PhP. 60.00) per insured (Section 22 of the Local Government Code of 1991), and to pay the stipend and allowance to the SPES beneficiaries, prior authorization from the Sanggunian is necessary before the City Mayor may sign the proposed MOA: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the City Government of Manila through the Honorable Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, to enter into a Memorandum of Agreement with the Philippine Red Cross for the provision of Personal Accident Insurance for the Special Program for Employment of Students beneficiaries of the City of Manila; and be it FURTHER

RESOLVED, that the Memorandum of Agreement (MOA) to be entered into by the parties authorized by this Resolution shall be submitted to the City Council for ratification.
