WHEREAS, the VICARIATO OF STO. NIÑO DE TONDO BEC MULTIPURPOSE COOPERATIVE, with office address at Sto. Niño de Tondo Parish, 600 Lorenzo Chacon Street, Tondo, Manila, a duly registered organization with the Cooperative Development Authority (CDA) is seeking accreditation as registered Cooperative;

WHEREAS, VICARIATO OF STO. NIÑO DE TONDO BEC MULTIPURPOSE COOPERATIVE, aims to contribute in the upliftment and development of the quality of life, not only of the members, but also of the less fortunate members of the society, as well as launching various humanitarian and livelihood programs that are designed to promote self-reliance and economic independence;

WHEREAS, the Association's purposes which are stated in Tagalog are as follows:

1. PAGHUHUBOG:

 - c. Coop. ownership/basic Coop. orientation
 - d. Retreat at recollection;

2. PANGKABUHAYAN:

- I. Pagbuo ng mga patakaran at panuntunan sa lahat ng programang kooperatiba;
- II. Paghihikayat sa mga kasapi na mag-impok at maglagak ng saping capital (Share Capital);
- III. Pagtuturo ng mga kasanayan sa pagnenegosyo at hanapbuhay;

3. PAGTULONG SA PAGBUO AT PAGPAPATATAG NG BEC SA BIKARYATO:

- I. Tumulong sa pagbubuo ng mga Coop. bukluran at pagbibigay ng BEC seminars;
- II. Tumulong sa paghuhubog at pagpapalitaw ng mga BEC facilitators at bukluran coordinators;
- III. Magdiwang o magsagawa ng Coop-BEC assembly minsan isang taon;

WHEREAS, the same organization submitted the accomplished requisites and supporting documents for purposes of accreditation;

WHEREAS, after careful study and perusal of all the requirements submitted, it was established that it has all the qualifications to be accredited as a Cooperative of Manila: NOW, THEREFORE, be it


