WHEREAS, the City of Manila is committed to enhancing its revenue streams for the betterment of its citizens;

WHEREAS, observations made during the budget hearings by the Committee on Appropriations revealed that certain departments have untapped potential for increased revenue generation;

WHEREAS, alongside these improvements, the introduction and implementation of digital solutions are crucial for the efficient collection and management of revenue;

WHEREAS, there is also a pressing need to consider revising the 2013 Omnibus Revenue Code of the City of Manila, to reflect current economic conditions and improve revenue generation;

WHEREAS, the formation of a Special Committee is thus imperative to undertake the strategic improvement of these departments, including the integration of digital technologies;

WHEREAS, this committee will consist of members skilled in finance, digital technology, and administrative operations, appointed by the City Council to spearhead this initiative;

WHEREAS, the committee's mandate will be to conduct an in-depth review of current revenue processes, identify areas for digital enhancement, and propose updates to the revenue code;

WHEREAS, the City Council pledges full support and resources for the effective functioning of this committee: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to establish, as it hereby establishes a Special Ad Hoc Committee for the strategic improvement of revenue-generating departments in the City of Manila; and be it FURTHER


