WHEREAS, the contractor, Leonel Waste Management Corporation, was awarded the project for garbage collection and disposal services for the period February 3, 2023 to December 31, 2023 in a public bidding conducted by the City of Manila on January 17, 2023 pursuant RA 9184, otherwise known as "The Government Procurement Reform Act";

WHEREAS, the Contractor have met the eligibility requirements prescribed by the City of Manila and have submitted the single calculated and responsive bid in the amount of Seven Hundred Seventy-Five Million Five Hundred Thousand Pesos (PhP. 775,500,000.00): NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to ratify, as it hereby ratifies the contract entered into by and between the City Government of Manila and Leonel Waste Management Corporation dated January 27, 2023 for garbage collection and disposal services for the period February 1, 2023 to December 31, 2023.
