RESOLUTION NO. 639 Series of 2023

RESOLUTION ENCOURAGING THE PAMANTASAN NG LUNGSOD NG MAYNILA TO ASSERT THAT SEVENTY-FIVE PERCENT (75%) OF ITS STUDENT POPULATION SHALL BE COMPRISED OF MANILA RESIDENTS AND TWENTY-FIVE PERCENT (25%) OF THE SAME TO NON-MANILA RESIDENTS

WHEREAS, the Pamantasan ng Lungsod ng Maynila (PLM) was established in 1951 by the virtue of Ordinance No. 4202 approved on 13 January 1960 during the administration of Mayor Arsenio H. Lacson;

WHEREAS, the Board's committee that spearheaded and allocated funds for the creation of the city university, in support of Mayor Lacson's educational program, was chaired by then Councilor Ernesto M. Maceda;

WHEREAS, in 1964, the then Congressman Justo R. Albert of the 4th congressional district of the City of Manila sponsored House Bill No. 8349, seeking to create the city university. The Senate version was spearheaded by Senators Gil Puyat and Camilo Osias:

WHEREAS, on 19 June 1965, President Diosdado P. Macapagal signed Republic Act No. 4196 that authorized the City of Manila to establish and operate the Pamantasan ng Lungsod ng Maynila by virtue of the creation of the University Charter to provide quality education that Manila residents deserve;

WHEREAS, latest statistics of the Pamantasan have it that for regular programs there are 10,713 students who are bona fide residents of the city while 3,430 students reside elsewhere, while for graduate programs there are 428 students who are true blue Manileños while 1,282 students come from other localities;

WHEREAS, the city-operated university is highly encouraged to assertively maintain a 75 percent allocation of its student population to Manila residents to ensure that majority of Manileños have an access and receive quality education: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to encourage, as it hereby encourages the Pamantasan ng Lungsod ng Maynila to assert that Seventy-Five Percent (75%) of its student population shall be comprised of Manila residents and Twenty-Five Percent (25%) of the same to non-Manila residents; and be it FURTHER

RESOLVED, that copies of this Resolution be furnished the Pamantasan ng Lungsod ng Maynila (PLM) and the Manila Public Information Office (MPIO), for publishing on its social media platforms.
