## RESOLUTION NO. 640 Series of 2023

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS, REPRESENTING THE CITY GOVERNMENT OF MANILA TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE HELEN KELLER INTERNATIONAL, FOR THE IMPLEMENTATION OF THE INFANT AND CHILD PRACTICES AND EARLY CHILDHOOD CARE AND DEVELOPMENT IN BARANGAY 20, PAROLA, TONDO, MANILA

WHEREAS, on November 21, 2023, the City Council of Manila was in receipt of letter from Atty. Marlon M. Lacson, Secretary to the Mayor, requesting for adoption of a resolution granting the Local Chief Executive authority to enter into a Memorandum of Understanding (MOU) with the Helen Keller International, for the implementation of the infant and child practices and early childhood care and development in Barangay 20, Parola, Tondo, Manila;

WHEREAS, the Barangay First 1,000 Days (BF1KD) and Early Childhood Care and Development (ECCD) interventions are implemented in Barangay 20, Parola, Tondo, Manila in collaboration with the Manila City Health Department - Office of Nutrition Services, and Manila Department of Social Welfare for a period of seventeen (17) months, or from July 2023 to November 30, 2024;

WHEREAS, the said project is funded by The Church of Jesus Christ- The Latter Days Saints and Helen Keller International: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the Honorable City Mayor, Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, representing the City Government of Manila to enter into a Memorandum of Understanding with the Helen Keller International, for the implementation of the Infant and Child Practices and Early Childhood Care and Development in Barangay 20, Parola, Tondo, Manila; and be it FURTHER

RESOLVED, that the executed Memorandum of Understanding (MOU) to be entered into by the parties authorized by this Resolution must pass the scrutiny and ratification of this Sanggunian.
