WHEREAS, the PEOPLE'S SOLIDARITY IN ISLA PUTING BATO (PESO IN IPB), INC., with office address at Purok 4 Isla Puting Bato, Barangay 20, Zone 2, District I, Tondo, Manila, a duly registered organization with the Securities and Exchange Commission (SEC), is seeking accreditation as registered Non-Governmental Organization (NGO);

WHEREAS, PEOPLE'S SOLIDARITY IN ISLA PUTING BATO (PESO IN IPB), INC., aims to contribute in the upliftment and development of the quality of life, not only of the members, but also of the less fortunate members of the society, as well as launching various humanitarian and livelihood programs that are designed to promote self-reliance and economic independence;

RESOLVED, by the City Council of Manila to grant, as it hereby grants the accreditation of People's Solidarity in Isla Puting Bato (PESO IN IPB), Inc., to become an accredited Non-Governmental Organization of the City of Manila; and be it FURTHER

RESOLVED, that a corresponding Certificate of Accreditation be attached hereto and be issued to the said association; and be it FINALLY

RESOLVED, that copies of this Resolution be furnished the Department of the Interior and Local Government (DILG) and the NGO concerned.
