**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS, TO ENTER INTO A CONTRACT OF AFFILIATION WITH THE ADAMSON UNIVERSITY, FOR THE TRAINING OF ITS STUDENTS IN THE FIELD OF MEDICINE, NURSING, MEDICAL TECHNOLOGY, PHYSICAL THERAPY, DENTISTRY, PHARMACY AND RADIOLOGIC TECHNOLOGY AT THE OSPITAL NG TONDO**

WHEREAS, in a letter dated 16 October 2023, the Secretary to the Mayor, Atty. Marlon M. Lacson, has requested for passage of a resolution granting authority to the Chief Executive of the city to enter into a Contract of Affiliation with a specific school offering medical-related courses, for the training of its students in the field of Medicine, Nursing, Medical Technology, Physical Therapy, Dentistry, Pharmacy and Radiologic Technology at the Ospital ng Tondo. The letter comes with a draft instrument;


WHEREAS, a similar request has passed the scrutiny of the City Legal Officer before, who opined that such draft Contract of Affiliation and the undertakings specified therein is consistent with the City Government of Manila's exercise of powers under General Welfare, specifically Section 16 of Republic Act No. 7160. However, it is recommended that prior authority from the City Council must first be secured before the City Mayor is made to sign the Agreement on behalf of the City Government of Manila;

WHEREAS, the draft Contract of Affiliation has reached the open session of the policy-making body and after a brief discussion, reached a consensus to approve the request: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the Honorable City Mayor, Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, to enter into a Contract of Affiliation with the Adamson University for the training of its students in the field of Medicine, Nursing, Medical Technology, Physical Therapy, Dentistry, Pharmacy and Radiologic Technology at the Ospital ng Tondo; and be it FURTHER

RESOLVED, that the Contract of Affiliation to be entered into by the parties authorized by this Resolution must pass the scrutiny and ratification of this Sanggunian.
