## **ORDINANCE NO. 8995**

AN ORDINANCE FURTHERMORE AMENDING SECTION 2.A OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF ALTURA EXTENSION TRICYCLE OPERATORS DRIVERS ASSN. INC. (ALTEX TODA) OF SAMPALOC, MANILA AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

#### **EXPLANATORY NOTE**

The ALTURA EXTENSION TRICYCLE OPERATORS DRIVERS ASSN. INC. (ALTEX TODA), is a duly registered Non-Stock Corporation at the Securities and Exchange Commission (SEC) on 6<sup>th</sup> day of September 2019.

The Manila Tricycle Regulatory Office (MTRO), likewise certified ALTURA EXTENSION TRICYCLE OPERATORS DRIVERS ASSN. INC (ALTEX TODA) as an authorized Tricycle Operators and Drivers Association (TODA) and was issued with Tricycle Franchise or Certificate of Public Conveyance Authority to Operate (CPCAO) in the City of Manila.

Barangay 593, Zone 58, through its Resolution No. 1, Series of 2020, adopted on 6<sup>th</sup> day of January 2020, allowing the use of a small portion of ALTURA EXTENSION as ALTEX TODA'S permanent terminal of ALTEX TODA particularly located at 353 ALTURA Extension, Barangay 593, Sampaloc, Manila.

Barangay 592, Zone 58 of District VI, Barangay 621, Zone 62 of District VI and Barangay 593, Zone 58, have issued their Certification permitting ALTEX TODA to pass through the listed added route that would traverse some streets of the mentioned barangay.

Be it ordained by the City Council of Manila, in session assembled, THAT:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of ALTURA EXTENSION TRICYCLE OPERATORS DRIVERS ASSN. INC (ALTEX TODA) OF SAMPALOC, MANILA, to read as follows:

#### "ALTURA EXTENSION TRICYCLE OPERATORS DRIVERS ASSN. INC (ALTEX TODA)

### **Loading and Unloading Areas**

- a. Ramon Magsaysay Service Road corner Altura Extension (in front of Puregold); and
- b. Old Sta. Mesa Street corner Albina Street."

**SEC. 2.** Section 2 of Ordinance No. 7871, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of ALTURA EXTENSION TRICYCLE OPERATORS DRIVERS ASSN. INC (ALTEX TODA), to read as follows:

#### "ASSOCIATION

R.M.C

ALTURA EXTENSION TRICYCLE OPERATORS DRIVERS ASSN. INC (ALTEX TODA)

100 Units

#### **ROUTE**

The authorized route lines of operation shall be via Altura Extension, Albina Street, Francisco Street to Pandacan Bridge, Cordillera, Bacood Teresa and vice-versa."

SEC. 3. Effectivity Clause. - This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on October 3, 2023.
