AN ORDINANCE AMENDING CITY ORDINANCE NO. 8206, OTHERWISE KNOWN AS "AN ORDINANCE ESTABLISHING A DISTRICT HOSPITAL IN THE SIXTH DISTRICT OF MANILA, DEFINING ITS FUNCTIONS AND PROVIDING FOR ITS ORGANIZATIONAL STRUCTURE, AND FOR OTHER PURPOSES", THEREBY ESTABLISHING STA. ANA HOSPITAL AS LEVEL 3 GENERAL HOSPITAL IN THE SIXTH DISTRICT OF MANILA

EXPLANATORY NOTE

On December 8, 2009, the Sangguniang Panlungsod ng Maynila enacted City Ordinance No. 8206, entitled: "AN ORDINANCE ESTABLISHING A DISTRICT HOSPITAL IN THE SIXTH DISTRICT OF MANILA, DEFINING ITS FUNCTIONS AND PROVIDING FOR ITS ORGANIZATIONAL STRUCTURE, AND FOR OTHER PURPOSES". The ordinance was approved by the Mayor on December 29, 2009.

Section 2 of the stated City Ordinance provides that a Level 3 specialty trauma center hospital shall be established in the Sixth District of Manila. The said hospital is known as the STA. ANA HOSPITAL.

During the early stages of its operations, Sta. Ana Hospital was given a license to operate as a Level 2 Hospital by the Department of Health. The Hospital has a three hundred (300) bed capacity which is not compliant with the Level 3 classification set by the Department of Health.

The Sta. Ana Hospital has been doing its part in recent years in the provision of basic health services as well as spearheading the fight during the dreadful COVID-19 pandemic. The hospital has immensely improved in terms of providing healthcare services to the residents of the City of Manila.

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2 of Ordinance 8206 is hereby amended and shall now read as follows:

- "SEC. 2. There is hereby established in the Sixth District of Manila a Level 3 General Hospital known as the Sta. Ana Hospital."
- **SEC. 2.** Section 3 of Ordinance 8206 shall also be amended and shall now read as follows:
 - "SEC. 3. Listed below are the adequate medical, hospital and administrative services which will be provided by the hospital to the residents of the City of Manila:

- SEC. 3. Separability Clause. If any portion or provision of this Ordinance is declared void or unconstitutional, the remaining portions or provisions which are not declared as such, shall remain effective.

SEC. 4. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on October 12, 2023.
