**ORDINANCE NO. 9013**

**AN ORDINANCE** FURTHERMORE AMENDING SECTION 2.A OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF BUENOS AIRES, MANGGA, MINDANAO, VISAYAN TODA (BUEMAMIV TODA) INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of Buenos Aires, Mangga, Mindanao, Visayan TODA (BUEMAMIV TODA) Inc., to read as follows:

**“BUENOS AIRES, MANGGA, MINDANAO, VISAYAN TODA  
(BUEMAMIV TODA) INC.**

**Loading and Unloading Area**

- a. Buenos Aires going to Mangga Avenue corner Altura Street.”

**SEC. 2.** Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Buenos Aires, Mangga, Mindanao, Visayan TODA (BUEMAMIV TODA) Inc., to read as follows:

**“ASSOCIATION**

**R.M.C.**

BUENOS AIRES, MANGGA,  
MINDANAO, VISAYAN TODA  
(BUEMAMIV TODA) INC.

15 Units

**ROUTE**

The authorized route lines of operation shall be via Buenos Aires, Altura, Samar Street, Mangga Avenue, Piña Avenue, Mindanao Avenue, Visayan Avenue and vice-versa.”


**SEC. 3. Separability Clause.** – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

**SEC. 4. Repealing Clause.** – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SEC. 5. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on December 5, 2023.




