AN ORDINANCE AUGMENTING VARIOUS ITEMS UNDER MAINTENANCE AND OTHER OPERATING EXPENSES THROUGH SAVINGS FROM THE FY 2023 ANNUAL BUDGET TO FUND THE ADDITIONAL REQUIREMENTS OF VARIOUS ACCOUNTS UNDER MAINTENANCE AND OTHER OPERATING EXPENSES APPROPRIATIONS IN THE TOTAL AMOUNT OF SIXTY-FOUR MILLION SIX HUNDRED FORTY-TWO THOUSAND FOUR HUNDRED FORTY-SEVEN PESOS (PHP. 64,642,447.00) AND FOR OTHER PURPOSES

EXPLANATORY NOTE

Ordinance No. 8919, appropriated funds for various items under the Maintenance and Other Operating Expenses (MOOE) of the FY 2023 Annual Budget.

However, after due consideration, there is a need to augment certain items from the FY 2023 Annual Budget through savings from other accounts of the FY 2023 Annual Budget to ensure the effective and continuous delivery of priority programs and activities as well as basic services in the City of Manila.

The City Treasurer and the City Accountant has issued the Declaration of Savings as supporting document to the said savings and augmentation.

As provided under Section 336 of the Local Government Code, Use of Appropriated Funds and Savings, funds shall be available exclusively for the specific purpose for which they have been appropriated. No ordinance shall be passed authorizing any transfer of appropriations from one item to another. However, the local chief executive or the presiding officer of the sanggunian concerned may, by ordinance, be authorized to augment an item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

The various Offices, Bureaus and Departments of the City Government of Manila, requires the use of basic utilities in its daily operations. Hence, to maintain the proper and continuous operations of the various Offices, augmentation of the accounts Electricity Expenses and Water Expenses is deemed necessary.

Further, the Department of Labor and Employment-National Wages and Productivity Commission approved Wage Order No. NCR-24 on 26 June 2023 providing for a minimum wage increase in the National Capital Region in the amount of Forty Pesos (PhP. 40.00) for all minimum wage earners in the private sector, therefore augmentation of funds for the accounts Janitorial Services and Security Services is inevitable to cover the increase in the basic salary of workers contracted by the City Government under the said accounts.

Finally, augmentation of the account Advertising Expenses is necessary since Resolutions and Ordinances promulgated by the City Council requires the same to be published in a newspaper of general circulation.
