AN ORDINANCE FURTHERMORE AMENDING SECTION 2.A OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF LARDIZABAL-ESPAÑA TRICYCLE OPERATOR'S AND DRIVER'S ASSOCIATION, INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of Lardizabal-España Tricycle Operator's and Driver's Association, Inc., to read as follows:

"LARDIZABAL-ESPAÑA TRICYCLE OPERATOR'S AND DRIVER'S ASSOCIATION, INC.

Loading and Unloading Area

- a. Lardizabal Street,
- b. P. Noval Street corner España"
- SEC. 2. Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Lardizabal-España Tricycle Operator's and Driver's Association, Inc., to read as follows:

"ASSOCIATION

R.M.C.

LARDIZABAL-ESPAÑA TRICYCLE OPERATOR'S AND DRIVER'S ASSOCIATION, INC.

25 Units

ROUTE

The authorized route lines of operation shall be via Lardizabal Street – San Anton Street – Reten Street – P. Noval Street – España Blvd. – Earnshaw Blvd. – Cayco St."

- SEC. 3. Separability Clause. If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.
- SEC. 4. Repealing Clause. All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.
 - SEC. 5. Effectivity Clause. This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on January 30, 2024.
