**ORDINANCE NO. 9024**

**AN ORDINANCE FURTHERMORE AMENDING SECTION 2.A OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF LARDIZABAL-ESPAÑA TRICYCLE OPERATOR'S AND DRIVER'S ASSOCIATION, INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY**

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of Lardizabal-España Tricycle Operator's and Driver's Association, Inc., to read as follows:

**“LARDIZABAL-ESPAÑA TRICYCLE OPERATOR’S AND DRIVER’S ASSOCIATION, INC.**

**Loading and Unloading Area**

- a. Lardizabal Street,
- b. P. Noval Street corner España”

**SEC. 2.** Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of Lardizabal-España Tricycle Operator's and Driver's Association, Inc., to read as follows:

**“ASSOCIATION**

**R.M.C.**

LARDIZABAL-ESPAÑA TRICYCLE OPERATOR’S AND DRIVER’S ASSOCIATION, INC.

25 Units

**ROUTE**

The authorized route lines of operation shall be via Lardizabal Street – San Anton Street – Reten Street – P. Noval Street – España Blvd. – Earnshaw Blvd. – Cayco St.”

**SEC. 3. Separability Clause.** – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.


**SEC. 4. Repealing Clause.** – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SEC. 5. Effectivity Clause.** – This Ordinance shall take effect upon its approval.
