**AN ORDINANCE** INSTITUTIONALIZING THE IMPLEMENTATION OF THE  
PANTAWID PAMILYA PILIPINO PROGRAM (4PS) IN THE CITY OF MANILA


## **EXPLANATORY NOTE**

The State shall promote a just and dynamic social order thereby uplifting its citizens and marginalized sectors from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all. The State further recognizes the need to foster social justice as provided for in Article XIII of the 1987 Constitution.

The Pantawid Pamilyang Pilipino Program (4Ps) is the national poverty reduction strategy and a human capital investment program that provides conditional cash transfer to poor households for a maximum period of seven (7) years, to improve the health, nutrition and education aspect of their lives as provided for under Republic Act No. 11310 pursuant to the above constitutional mandate.

The City Government of Manila recognizes its role in ensuring inclusive development and commits to address the needs of the poor within its jurisdiction.

The Sangguniang Panlungsod of the City of Manila, in support of the Pantawid Pamilyang Pilipino Program of the National Government hereby institutionalized and expanded the benefits of this program in order to further improve the gains reached by the 4Ps beneficiaries-residents in the City of Manila.

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1. Short Title.** - This shall otherwise be known as the "Expanded Pantawid Pamilyang Pilipino Program (4Ps) Ordinance of the City of Manila".

**SEC. 2. Applicability.** - This Ordinance is applicable to all qualified Pantawid Pamilyang Pilipino Program (4Ps) Beneficiaries under Republic Act No. 11310 residing in the City of Manila.

**SEC. 3. Definition of Terms.** - As used in this Ordinance, the following terms are hereby defined as follows:

- a. **Beneficiaries** refers to the households identified by the DSWD for entitlement to the monthly conditional cash grants as provided under Republic Act No. 11310 residing in the City of Manila.
- b. **Benefits** refers to the expanded benefits described in Section 4 of this Ordinance.
- c. **Institutionalization** refers to the expansion of the benefits of the Pantawid Pamilyang Pilipino Program (4Ps) to be received by the qualified beneficiaries of the program who are residents of the City of Manila.
- d. **Kilos Unlad Care Management Framework** refers to the social case management strategy which aims to guide the households in achieving improved well-being from survival to subsistence to eventually self-sufficiency.

**SEC. 4. Expanded Benefits of the Pantawid Pamilyang Pilipino Program (4Ps).** - Notwithstanding the mandate under Republic Act No. 11310 is unto the National Government, its agencies and instrumentalities, by this local legislation, the City of Manila formally imposes unto itself the obligation of providing interventions to the 4Ps beneficiaries and their families such as:

- a. Guaranteed and continued preferential access to the City Social Services and Welfare Programs.
- b. Grant of city scholarships or educational support to 4Ps Beneficiaries Qualified Dependents under existing Education Program of the City.
- c. Employment assistance of the 4Ps beneficiaries and their Qualified Dependents through the City's Public Employment Service Office (PESO).
- d. Medical assistance through the City Health Department and Social Welfare Department.
- e. Social protection services to qualified sectors (person with disability, senior citizen, solo parent) provided by the City Government of Manila.
- f. Other needed interventions/services which can be provided by the City's Local Advisory Council members based on assessment and qualifications. Specifically, in the conduct of 4Ps graduation ceremonies of all Manila City candidates for exit/graduation from the program.

**SEC. 5. Strengthening the Local Advisory Council and Its Sub Committee/Teams.** - The City Government created the Local Advisory Council headed by the Local Chief Executive as Chairperson and the concerned Heads of Offices as Members providing social protection programs on education, skills, health, nutrition, housing, employment, economic, and the like. They convene as scheduled and report their respective accomplishments in aiding the 4Ps beneficiaries.



The Local Advisory Council shall recognize sub-committees/teams which are deemed necessary for the support of institutionalizing the expanded benefits of the 4Ps beneficiaries in the City of Manila, to wit:

- a. **Case Management Team** - Aggrupation whose function is to plan interventions to be provided to 4Ps household based on assessed needs using the Kilos Unlad Case Management tools to help them improve their level of well-being upon entry and until they graduated/exit from the program.
- b. **Family Development Session (FDS) Team** - The FDS Team shall act as subject matter experts or resource persons on areas of concerns. They shall likewise aim to provide a venue for 4Ps beneficiaries to enhance and acquire new skills and knowledge responding to their parental roles and responsibilities promoting the concept of shared parenting.

The DSWD-NCR implementer of the FDS shall monitor the over-all conduct of the FDS including its impact on the beneficiaries and prepare reportorial requirements in accordance with the set templates and timelines. It shall also propose enhancements and/or new developments to existing policies and FDS materials.

- c. **Barangay Local Action Team (LAT)/Committee** - The Barangay LAT/Committee shall replicate the function of the Local Advisory Council in the barangay level with its funding included in the Barangay Plan.

**SEC. 6. Funding.** - The City Government shall allocate the funds necessary to cover the expenses needed for the implementation of this Ordinance and its projects, programs and activities.

**SEC. 7. Formulation of Internal Rules and Regulations.** - The Local Advisory Council, in coordination with the City Legal Office shall formulate within sixty (60) days upon the effectivity of this Ordinance the corresponding Internal Rules and Regulations (IRR) for the proper implementation of this Ordinance and submit the same to the City Council of Manila for its ratification.

The IRR shall include the creation of a Technical Working Group composed of representatives from the Manila Department of Social Welfare (MDSW), the City Legal Office, City Planning and Development Office (CPDO), the Public Employment Service Office (PESO), and the Manila Health Department (MHD) among others.

**SEC. 8. Governing Law.** - In the implementation of this Ordinance, the provisions of Republic Act No. 11310, otherwise known as the Pantawid Pamilyang Pilipino Program (4Ps) Act and its implementing rules and regulations, shall be deemed written unto this Ordinance.

**SEC. 9. Separability Clause.** - In the event that any section or provision of this Ordinance is declared unconstitutional or invalid, other section or provisions unaffected shall remain valid and effective.

**SEC. 10. Repealing Clause.** - All prior inconsistent ordinances are hereby repealed and/or modified accordingly.

**SEC. 4. Effectivity Clause.** - This Ordinance shall take effect immediately, and shall continue to be in force and effect until revoked or set aside.

This Ordinance was finally enacted by the City Council of Manila on January 30, 2024.




