**ORDINANCE NO. 9028**

**AN ORDINANCE** FURTHERMORE AMENDING SECTION 2.A OF ORDINANCE NO. 7755 (UNDER TRICYCLE TERMINALS), AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF RODRIGUEZ HIDALGO ARLEGUI BAUTISTA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (HABTODA) INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of Rodriguez Hidalgo Arlegui Bautista Tricycle Operators and Drivers Association (HABTODA) Inc., to read as follows:

**“RODRIGUEZ HIDALGO ARLEGUI BAUTISTA TRICYCLE OPERATORS  
AND DRIVERS ASSOCIATION (HABTODA) INC.**

**Loading and Unloading Areas**

- a. Arlegui Street corner Hidalgo Street
- b. Hidalgo Street corner Bautista Street
- c. Elizondo Street corner Gunao Street
- d. Bilibid Viejo Street corner Hidalgo Street”

**SEC. 2.** Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route lines of Rodriguez Hidalgo Arlegui Bautista Tricycle Operators and Drivers Association (HABTODA) Inc., to read as follows:

**“ASSOCIATION**

Rodriguez Hidalgo Arlegui Bautista  
Tricycle Operators and Drivers  
Association (HABTODA) Inc.

**R.M.C.**

120 Units

**ROUTE**

The authorized route lines of operation shall begin in the area of Arlegui Street corner Hidalgo Street to Hidalgo Street corner Bautista Street to Elizondo Street corner Gunao Street to Bilibid Viejo Street corner Hidalgo Street and vice-versa.”

**SEC. 3. Separability Clause.** – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.


**SEC. 4. Repealing Clause.** – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SEC. 5. Effectivity Clause.** – This Ordinance shall take effect upon its approval.


This Ordinance was finally enacted by the City Council of Manila on February 1, 2024.
