## **EXPLANATORY NOTE**

Ms. Gloria Romero is a Filipino actress known for her work in film and television. Romero has received numerous awards throughout her career, including several FAMAS Awards (Filipino Academy of Movie Arts and Sciences Awards) for Best Actress. As such, this Ordinance seeks to exempt the upcoming event hosted by Ms. Daisy Romualdez on February 28, 2024 at Manila Hotel from payment amusement tax and other incidental expenses for the event in recognition of the contributions of Ms. Gloria Romero to the entertainment industry, as well as an expression of gratitude for the charitable event held in her name.

Be it ordained by the City Council of Manila, in session assembled, THAT:

**SECTION 1.** Exemption from payment of mayor's permit, amusement tax and other incidental expenses in the upcoming event, entitled: "Tribute to the Queen" in honor of Ms. Gloria Romero, a pillar of the Philippine movie industry to be held at the Manila Hotel on February 28, 2024, is hereby granted and authorized.

**SECTION 2.** The grantee shall, within twenty (20) days after the holding of the event, submit a full accounting of the proceeds thereof to Her Honor, the Mayor and the City Council of Manila.

SEC. 3. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila February 22, 2024.
