WHEREAS, SPIRITUAL FILIPINO CATHOLIC CHURCH aims to contribute in the upliftment and development of the quality of life, not only of its members but also of the less fortunate members of the society as well as launching various humanitarian and livelihood programs designed to promote self-reliance and economic independence;

WHEREAS, the Association's purpose is to cultivate good human relations and the teachings of Christian lives, among men;

WHEREAS, the same organization submitted the accomplished requirements and supporting documents for purposes of accreditation;

WHEREAS, after a careful study and perusal of all the requirements submitted, it was established that it has all the qualifications to be accredited as a Non-Governmental Organization of Manila: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to recognize, as it hereby recognizes Spiritual Filipino Catholic Church, as an accredited Non-Governmental Organization of the City of Manila; and be it FURTHER

RESOLVED, that a corresponding Certificate of Accreditation be attached hereto and forthwith issued to the said association; and be it FINALLY

RESOLVED, that copies of this Resolution be furnished to the Department of the Interior and Local Government (DILG) and the NGO concerned.
