WHEREAS, Manuel Jefferson Wycoco Dela Fuente was born on 4 January 1960 in the City of Manila to Mr. Manuel F. Dela Fuente, Jr., the former Director of the Manila Barangay Bureau, and Mrs. Primitiva W. Dela Fuente and was the grandson of former Manila Mayor Hon. Manuel Dela Fuente;

WHEREAS, he started his thirty-three (33) years of public service on 20 July 1989 as a Legislative Staff Assistant in the City Council of Manila for five (5) years until his resignation, and on 15 March 1995, he returned as a clerk and was promoted to a local legislative assistant staff on 19 October 1998, wherein he was assigned at the Bulwagang Pulungan Danilo Lacuna until his passing:

WHEREAS, Manuel Jefferson W. Dela Fuente has gone ahead to meet his Creator, his parents Mr. Manuel F. Dela Fuente, Jr., Mrs. Primitiva W. Dela Fuente, and his siblings Manuel W. Dela Fuente II, Manuel W. Dela Fuente III, and Manuel Alan W. Dela Fuente, on the 22<sup>nd</sup> of January 2024 at the age of sixty-four (64), but his life on earth will not be counted by years, but by the memories he had left behind in the hearts of those who knew him well;

WHEREAS, he left behind a loving wife, Mrs. Maria Luisa Ubaldo-Dela Fuente, his children Manuel Jefferson U. Dela Fuente, Jr., Manuel Alejandro U. Dela Fuente, and Manuel Luijeson U. Dela Fuente, and his siblings Rebecca Dela Fuente-Conti, Violeta Dela Fuente-Lapid, Engr. Czarina Dela Fuente-Fernandez and Manuel Reynold W. Dela Fuente;

WHEREAS, the death of Manuel Jefferson W. Dela Fuente is a great loss not only to his immediate family and friends, but to everyone who has known him, for he was not only a devoted and loving husband and father but also a genial, benevolent and caring person to everyone that he had encountered in his professional life;

WHEREAS, the City Council of Manila is deeply saddened about the sudden death of Manuel Jefferson W. Dela Fuente, and despite this melancholic bereavement, the City Council of Manila takes pride and gratitude for his services and contributions to the City Government of Manila and its citizens: NOW THEREFORE, be it
