WHEREAS, by the virtue of Republic Act No. 8044, otherwise known as the “Youth in Nation-Building Act”, the National Youth Commission (NYC) is mandated to encourage youth involvement in character-building and development activities and to mobilize youth's abilities, talents and skills to redirect their creativity, inventive genius and wellspring of enthusiasm and hope for a better Philippine society;

WHEREAS, according to their website, the NYC's Youth Organization Registration Program (YORP) started as the National Registration Program (NRP) in 2001 with the aim to register, help and facilitate the establishment of youth organizations and youth-serving organizations;

WHEREAS, last year, the NYC screened YORP-registered organizations around the country and searched for those who exemplify extraordinary effort and contribution to the Philippine Youth Development Plan (PYDP), resulting in positive outputs and impacts that directly benefit the community and contribution to nation-building;

WHEREAS, among the 2023 Outstanding YORP Organization awardees was Barangay 128's Building Youth Empowerment Tondo (B.Y.E. Tondo) for their Tondo 1 Community Rollout project held on September 24, 2023 which aimed to involve the youth in addressing climate change and other environmental concerns in the community;


