RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS, REPRESENTING THE CITY GOVERNMENT OF MANILA, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH IGNACIO VILLAMOR SENIOR HIGH SCHOOL, FOR WORK IMMERSION PARTNERSHIP

WHEREAS, on February 12, 2024, the City Council of Manila was in receipt of a letter from Atty. Marion M. Lacson, Secretary to the Mayor, requesting for the adoption of a resolution granting the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with Ignacio Villamor Senior High School for Work Immersion Program of its students in consistent with Republic Act 10533, otherwise known as "An Act enhancing the Philippine Basic Education by Strengthening its Curriculum and Increasing the Number of Years for Basic Education, Appropriating Funds thereof and for other purposes”;

WHEREAS, the letter together with the proposed Memorandum of Agreement (MOA), was referred to the City Council for appropriate action;


WHEREAS, the Public Employment Services (PESO) recognizes the need for a work immersion partnership with different schools to provide positive impact to the community;

WHEREAS, the request has reached the attention of the policy-making body and after a brief discussion, reached a consensus to approve the request: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the Honorable City Mayor, Maria Sheilah “Honey” H. Lacuna-Pangan, MD, FPDS, representing the City Government of Manila, to enter into a Memorandum of Agreement with Ignacio Villamor Senior High School, for Work Immersion Partnership; and be it FURTHER

RESOLVED, that the duly executed Memorandum of Agreement (MOA) entered into by the parties authorized by this Resolution must pass the scrutiny and ratification of this Sanggunian.
