RESOLUTION SUPPORTING SENATE BILL NO. 2534, OTHERWISE KNOWN AS THE "P100 DAILY MINIMUM WAGE ACT OF 2023", PROVIDING FOR A ONE HUNDRED PESOS (PHP. 100.00) INCREASE IN DAILY MINIMUM WAGE FOR PRIVATE SECTOR EMPLOYEES AND WORKERS NATIONWIDE

WHEREAS, Senate Bill No. 2534 proposes a One Hundred Pesos (PhP. 100.00) increase in the daily minimum wage for all private sector employees and workers across the country, benefiting approximately 4.2 million minimum wage earners;

WHEREAS, the proposed measure aims to alleviate the economic burden faced by Filipinos amidst the escalating prices of essential goods and the rising cost of living;

WHEREAS, the enactment of SB 2534 is crucial in enhancing the purchasing power of consumers, stimulating economic activity and fostering national growth;

WHEREAS, the enactment of this wage hike bill aligns with the Philippine Development Plan's goal of reducing the poverty incidence rate to 13.2 percent by year 2025 and 9 percent by year 2028, ultimately striving for a prosperous, predominantly middle-class society by year 2040;

WHEREAS, this Sanggunian calls upon relevant government agencies and stakeholders to collaborate in ensuring the realization and enforcement of the proposed wage hike to achieve its intended socio-economic benefits.

WHEREAS, this Sanggunian pledges its commitment to continuously advocate for policies and initiatives that promote equitable economic growth and uplift the lives of all citizens in the City of Manila: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to support, as it hereby supports Senate Bill No. 2534, otherwise known as the "₱100 Daily Minimum Wage Act of 2023", providing for a One Hundred Pesos (PhP. 100.00) increase in daily minimum wage for private sector employees and workers nationwide; and be it FURTHER
