## RESOLUTION NO. 96 Series of 2024

RESOLUTION AUTHORIZING HONORABLE CITY MAYOR, MARIA SHEILAH "HONEY" LACUNA-PANGAN, MD, FPDS, REPRESENTING THE CITY GOVERNMENT OF MANILA, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PAMANTASAN NG LUNGSOD NG MAYNILA, FOR THE ON-THE-JOB-TRAINING OF ITS STUDENTS IN DIFFERENT OFFICES OF THE CITY

WHEREAS, in a letter dated February 19, 2024, the Secretary to the Mayor, Atty. Marlon M. Lacson, requested for adoption of a resolution granting the Chief Executive of the city to enter into a Memorandum of Agreement (MOA) with the Pamantasan ng Lungsod ng Maynila (PLM), for the on-the-job-training (OJT) of its students in different offices of the city;

WHEREAS, the letter-request, together with the proposed Memorandum of Agreement (MOA) was referred to the City Council for appropriate action;

WHEREAS, the Public Employment Services Office (PESO) recognizes the need for an on-the-job-training partnership with the school to provide positive impact to the community and commits to accommodate the students for proper training:

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes Honorable City Mayor, Maria Sheilah "Honey" Lacuna-Pangan, MD, FPDS, representing the City Government of Manila, to enter into a Memorandum of Agreement with the Pamantasan ng Lungsod ng Maynila, for the on-the-job-training of its students in different offices of the city; and be it FURTHER
