**RESOLUTION** AUTHORIZING THE CITY GOVERNMENT OF MANILA THROUGH THE HONORABLE MAYOR MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH TIMOTEO PAEZ INTEGRATED SCHOOL FOR WORK IMMERSION PARTNERSHIP

WHEREAS, in a letter dated 19 February 2024, the Secretary to the Mayor Atty. Marlon M. Lacson, requested for adoption of a resolution granting authority to the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with Timoteo Paez Integrated School for Work Immersion Partnership consistent with Republic Act No. 10533, entitled: "An Act enhancing the Philippine Basic Education System by strengthening its curriculum and increasing the number of years for basic education, appropriating funds thereof and for other purposes";

WHEREAS, the letter-request, together with the proposed Memorandum of Agreement was referred to the City Council for appropriate action;

WHEREAS, the Public Employment Services Office (PESO) recognizes the need for a work immersion partnership with the school, to provide positive impact to the community, and shall be facilitating online webinars, trainings, and/or other activities, for purposes of student work immersion;

WHEREAS, the instrument was presented to the Manila City Council which conducted discussion and deliberation on the merits of the matter and forthwith unanimously consented to the request: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the City Government of Manila through the Honorable Mayor Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, to enter into a Memorandum of Agreement with Timoteo Paez Integrated School for Work Immersion Partnership; and be it FURTHER

RESOLVED, that the Memorandum of Agreement to be entered into by the parties authorized by this Resolution shall be submitted to the City Council for ratification.
