ORDINANCE NO. 9032

AN ORDINANCE FURTHER AMENDING SECTION 2.A (5) OF ORDINANCE NO. 7755 (UNDER JEEPNEY TERMINALS), AS AMENDED

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Section 2.a (5) of Ordinance No. 7755 (under Jeepney Terminals) is hereby further amended to read as follows:

"BLUMENTRITT-ESPAÑA JEEPNEY OPERATORS DRIVERS ASSN.

Loading and Unloading Areas

- a. Cavite Street corner Isagani Street
- b. Blumentritt Ext. corner España Street"
- **SEC. 2.** If, for any reason or reasons, any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.
- **SEC. 3.** All ordinances, rules or regulations in conflict with the provisions of this Ordinance are hereby repealed; PROVIDED, that the rights that are vested upon the effectivity of this Ordinance shall not be impaired.
 - **SEC. 4. Effectivity Clause.** This Ordinance shall take effect upon its approval.
