RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF MANILA THROUGH THE HONORABLE MAYOR MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH POLYTECHNIC UNIVERSITY OF THE PHILIPPINES, FOR THE ON-THE-JOB TRAINING OF ITS STUDENTS IN THE CITY OF MANILA

WHEREAS, on March 6, 2024, the City Council of Manila was in receipt of a letter from Atty. Marlon M. Lacson, Secretary to the Mayor, requesting for adoption of a resolution granting authority to the Local Chief Executive to enter into a Memorandum of Agreement (MOA), for the on-the-job training of its students in the City of Manila;

WHEREAS, the proposed MOA underwent review by the City Legal Officer and found the same to be in order but stated that prior authorization from the City Council is necessary before the Mayor may sign the Contract for and on behalf of the city;


WHEREAS, the Public Employment Services (PESO) recognizes the need for an on-the-job training partnership with the school to provide positive impact to the community and commits to accommodate the trainees in different offices of the city;

WHEREAS, the Manila City Council conducted discussion and deliberation on the merits of the matter and forthwith unanimously consented to the request: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the City Government of Manila through the Honorable Mayor Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, to enter into a Memorandum of Agreement with Polytechnic University of the Philippines, for the on-the-job training of its students in the City of Manila; and be it FURTHER

RESOLVED, that the duly executed Memorandum of Agreement (MOA) entered into by the parties authorized by this Resolution must pass the scrutiny and ratification of this Sanggunian.


