WHEREAS, MANILA BARANGAY CHAIRMEN ASSOCIATION OF DISTRICT 5 (MBCAD5) INC., with office address at 1903 Vasquez Street, Barangay 703, Zone 77, District V, Malate, Manila, a duly registered organization with the Securities and Exchange Commission (SEC), is seeking accreditation as a registered People's Organization (PO);

- 6. To assist in the total development of the individual member intellectually, spiritually, socially, morally, and physically; and**
- 7. To contract, rent, buy, or sell, hold and manage personal or real property necessary for the furtherance of the purposes of the Organization.**

WHEREAS, the same organization submitted the accomplished requirements and supporting documents for purposes of accreditation;

WHEREAS, after a careful study and perusal of all the requirements submitted, it was established that it has all the qualifications to be accredited as a People's Organization of Manila: NOW, THEREFORE, be it


