WHEREAS, the City Council of Manila recognizes the importance of job creation and economic development in improving the lives of its constituents;

WHEREAS, Senate Majority Leader Joel Villanueva has expressed gratitude to President Ferdinand R. Marcos Jr. for prioritizing job creation through the signing of the Tatak Pinoy Act and the Trabaho Para sa Bayan Act;

WHEREAS, Republic Act No. 11981, otherwise known as the Tatak Pinoy Act, aims to encourage, support and promote the production and offering of locally made products and services that are globally competitive, thereby creating employment opportunities for Filipinos and bolstering government job creation efforts;


WHEREAS, the Trabaho Para sa Bayan Act, signed on September 27, 2023, complements the Tatak Pinoy Act by establishing a national masterplan to address unemployment, underemployment and youth unemployment, further contributing to the government's efforts in job creation;

WHEREAS, both laws underscore the importance of developing human resources, promoting academe-industry linkages and enhancing the capabilities of domestic enterprises through various training, skills development and lifelong learning programs: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to commend, as it hereby commends the enactment of the Tatak Pinoy Act and the Trabaho Para sa Bayan Act, to further strengthen the government's efforts in job creation and economic development; and be it FURTHER
