RESOLUTION ADOPTING AND APPROVING RESOLUTION NO. 2, SERIES OF 2023 PASSED BY THE MANILA DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL ON SEPTEMBER 29, 2023, ENTITLED: "A RESOLUTION INSTITUTIONALIZING THE USE OF THE INCIDENT COMMAND SYSTEM AS AN ON-SCENE DISASTER RESPONSE AND MANAGEMENT MECHANISM"

WHEREAS, Rule 7, Section 3 (h) of the Implementing Rules and Regulations (IRR) of Republic Act No. 10121, also known as the "Philippine Disaster Risk Reduction and Management Act of 2010", states that:

-XXX-

(h) Establish an Incident Command System (ICS) as part of the country's existing on-scene disaster response system, to ensure effective consequence management of disasters or emergencies;

WHEREAS, the National Disaster Risk Reduction and Management Council (NDRRMC) issued Memorandum Circular No. 04, Series of 2012 on March 28, 2012, which provided for the Implementing Guidelines on the Use of Incident Command System (ICS) as an on-scene disaster response and management mechanism under the Philippine Disaster Risk Reduction Management System (PDRRMS);

WHEREAS, the Department of Interior and Local Government (DILG) issued Memorandum Circular No. 2015-76 dated July 21, 2015, which directed all Provincial Governors, City Mayors, Municipal Mayors, Punong Barangays, Regional Governors of Autonomous Region in Muslim Mindanao (ARMM), DILG-ARMM, Regional Secretary, DILG Regional Directors, and all others concerned, to establish the ICS as an on-scene response management mechanism which shall be activated in response to disasters and emergencies;

WHEREAS, institutionalizing the ICS, a standard on-scene, all-hazards incident management system, already used by firefighters, rescuers, emergency medical teams and the Manila Disaster Risk Reduction Management Office (MDRRMO), shall enable the city officials, incident managers, and emergency organizations at all jurisdictional levels to appropriately delegate to the Unified Commanders the authority to manage the incident: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to adopt and approve, as it hereby adopts and approves Resolution No. 2, Series of 2023 passed by the Manila Disaster Risk Reduction and Management Council on September 29, 2023, entitled: "A RESOLUTION INSTITUTIONALIZING THE USE OF THE INCIDENT COMMAND SYSTEM AS AN ON-SCENE DISASTER RESPONSE AND MANAGEMENT MECHANISM".
