WHEREAS, Mayor Maria Sheilah "Honey" Lacuna-Pangan, MD, FPDS led the celebration of the 3<sup>rd</sup> Manila Women's Summit on March 19, 2024 at the Open Air Auditorium in Rizal Park;

WHEREAS, Women's Summit aims to empower women of all backgrounds to determine their potential as well as to explore avenues for improvement. It cultivates a supportive community that honors diversity and gives importance to women;
