

**SEC. 4. Effectivity Clause.** – This Ordinance shall take effect upon its approval.



## **E R R A T U M**

Please be informed of the following corrections in Ordinance No. 9017, entitled *An Ordinance Bequeathing Honors to the Late Vice Mayor Danilo B. Lacuna by Naming the Hallway of the Main Building of Dr. Alejandro Albert Elementary School in his Name, Located at 2110 Dapitan Street in the Fourth District of Manila*, enacted by the City Council of Manila last December 12, 2023.

The title of the Ordinance should be read as follows:

**"An Ordinance Bequeathing Honors to the Late Vice Mayor Danilo B. Lacuna by Naming the Auditorium of the Main Building of Dr. Alejandro Albert Elementary School in his Name, Located at 2110 Dapitan Street in the Fourth District of Manila"**

Furthermore, on Section 1, the word "Hallway" must also be replaced with "Auditorium". As corrected, it should be read as follows:

**SECTION 1.** The auditorium of the main building of Dr. Alejandro Albert Elementary School located at 2110 Dapitan Street in the Fourth District in the City of Manila shall hereby be named the **"DANILO B. LACUNA AUDITORIUM"**.
