**AN ORDINANCE FURTHER AMENDING SECTION 2.A OF ORDINANCE NO. 7755, AS AMENDED, BY INCLUDING THEREIN THE LOADING AND UNLOADING AREAS OF SAN LORENZO DAMKA TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (SALORDA-TODA), INC. AND SECTION 2 OF ORDINANCE NO. 7871, AS AMENDED, BY INCLUDING THEREIN ITS ROUTE MEASURE CAPACITY**

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

**SECTION 1.** Section 2.a (Tricycle Terminals) of Ordinance No. 7755, as amended, is hereby furthermore amended, by including therein the loading and unloading areas of San Lorenzo Damka Tricycle Operators and Drivers Association (SALORDA-TODA), Inc., to read as follows:

**“SAN LORENZO DAMKA TRICYCLE OPERATORS AND DRIVERS  
ASSOCIATION (SALORDA-TODA), INC.**

**Loading and Unloading Areas**

- a. Waling Waling Street, San Lorenzo Street corner Damka Street
- b. Valenzuela Street corner Victorino Mapa Extension
- c. Old Sta. Mesa”

**SEC. 2.** Section 2 of Ordinance No. 7871, as amended, is hereby furthermore amended, by including therein the Route Measure Capacity and authorized route line of San Lorenzo Damka Tricycle Operators and Drivers Association (SALORDA-TODA), Inc., to read as follows:

**“ASSOCIATION**

**R.M.C.**

SAN LORENZO DAMKA  
TRICYCLE OPERATORS AND  
DRIVERS ASSOCIATION  
(SALORDA-TODA), INC.

30 Units

**ROUTE**

The authorized route lines of operation shall be via Waling Waling Street, San Lorenzo Street, Damka Street, V. Mapa Extension, Old Sta. Mesa.”

**SEC. 3. Separability Clause.** – If any part or provision of this Ordinance is held or declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.


**SEC. 4. Repealing Clause.** – All other local laws, decrees, orders, issuances, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SEC. 5. Effectivity Clause.** – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on March 19, 2024.
