RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS, REPRESENTING THE CITY GOVERNMENT OF MANILA, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE DEPARTMENT OF TOURISM TOURISM INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY, NATIONAL COMMISSION FOR CULTURE AND THE ARTS, NATIONAL HISTORICAL COMMISSION OF THE PHILIPPINES, NATIONAL MUSEUM AND PHILIPPINE POSTAL CORPORATION FOR THE RESTORATION OF THE MANILA CENTRAL POST OFFICE

WHEREAS, on April 15, 2024, the City Council of Manila was in receipt of transmittal from the Office of the Mayor, for review of draft Memorandum of Understanding (MOU) to be entered into among different government agencies and instrumentalities;

WHEREAS, the instrument will be beneficial to the residents of the City of Manila in its goal to preserve culture for the benefit of the general public;

WHEREAS, the request, together with the proposed Memorandum of Understanding was referred to the City Council for appropriate action;

WHEREAS, Section 22(c) of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991, empowers the Local Chief Executive to enter into contracts on behalf of the local government unit upon prior authorization by the sanggunian concerned: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the Honorable City Mayor, Maria Sheilah "Honey" Lacuna-Pangan, MD, FPDS, representing the City Government of Manila, to enter into a Memorandum of Understanding with the Department of Tourism Tourism Infrastructure and Enterprise Zone Authority, National Commission for Culture and Arts, National Historical Commission of the Philippines, National Museum, and Philippine Postal Corporation for the restoration of the Manila Central Post Office; and be it FURTHER

RESOLVED, that the duly executed Memorandum of Understanding entered into by the parties authorized by this Resolution must pass the scrutiny and ratification of this Sanggunian.
