RESOLUTION AUTHORIZING THE CITY GOVERNMENT OF MANILA THROUGH THE HONORABLE MAYOR MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH-METRO MANILA CENTER FOR HEALTH DEVELOPMENT FOR THE IMPLEMENTATION OF THE MEDICAL ASSISTANCE TO INDIGENT AND FINANCIALLY INCAPACITATED PATIENTS PROGRAM UNDER SUB-ALLOTMENT ADVICE NO. 2023-08-004326, DATED AUGUST 29, 2023 IN THE AMOUNT OF THREE MILLION PESOS (PHP. 3,000,000.00) TO ELIGIBLE PATIENTS OF THE OSPITAL NG MAYNILA MEDICAL CENTER

WHEREAS, in a letter dated 11 April 2024, the Secretary to the Mayor Atty. Marlon M. Lacson, requested for adoption of a resolution granting authority to the Local Chief Executive to enter into a Memorandum of Agreement (MOA) for the implementation of the Medical Assistance to Indigent and Financially Incapacitated Patients (MAIFIP) Program under Sub-Allotment Advice No. 2023-08-004326, dated August 29, 2023 in the amount of Three Million Pesos (PhP. 3,000,000.00) to eligible patients of the Ospital ng Maynila Medical Center;

WHEREAS, the letter-request, together with the proposed Memorandum of Agreement was referred to the Office of the Majority Floor Leader for appropriate action;

WHEREAS, the Manila City Council conducted discussion and deliberation on the merits of the matter and forthwith unanimously consented to the request: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the City Government of Manila through the Honorable Mayor Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, to enter into a Memorandum of Agreement with the Department of Health-Metro Manila Center for Health Development for the implementation of the Medical Assistance to Indigent and Financially Incapacitated Patients Program under Sub-Allotment Advice No. 2023-08-004326, dated August 29, 2023 in the amount of Three Million Pesos (PhP. 3,000,000.00) to eligible patients of the Ospital ng Maynila Medical Center.
