RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, MARIA SHEILAH "HONEY" H. LACUNA-PANGAN, MD, FPDS, TO ENTER INTO A CONTRACT OF AFFILIATION WITH THE PAMANTASAN NG LUNGSOD NG MAYNILA, COLLEGE OF MEDICINE, RELATIVE TO THE TRAINING OF DEPARTMENT OF FAMILY AND COMMUNITY MEDICINE (DFCM) MEDICAL CLERKS IN THE FIELD OF COMMUNITY MEDICINE AT THE MANILA HEALTH DEPARTMENT

WHEREAS, in a letter dated 18 March 2024, the Secretary to the Mayor, Atty. Marlon M. Lacson requested that the Chief Executive be given the authority to enter into a Contract of Affiliation with the Pamantasan ng Lungsod ng Maynila for the training of Department of Family and Community Medicine (DFCM) medical clerks at the Manila Health Department;

WHEREAS, a similar request has passed the scrutiny of the City Legal Officer before who opined that such draft Contract of Affiliation and the undertakings specified therein are consistent with the City Government of Manila's exercise of powers under General Welfare Clause, specifically Section 16 of Republic Act No. 7160 (Local Government Code of 1991). However, it is recommended that prior authority from the City Council must first be secured before the City Mayor is made to sign the Agreement on behalf of the city;

WHEREAS, the draft Contract of Affiliation has reached the consideration of the policy-making body and after a brief discussion and deliberation, agreed to approve the request: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the Honorable City Mayor, Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, to enter into a Contract of Affiliation with the Pamantasan ng Lungsod ng Maynila, College of Medicine, relative to the training of Department of Family and Community Medicine (DFCM) medical clerks in the field of Community Medicine at the Manila Health Department.
