Lacson, Secretary to the Mayor, requesting for adoption of a resolution granting the Local Chief Executive authority to sign a Deed of Donation and Acceptance (DDA) involving one (1) unit mobile laboratory;


WHEREAS, the letter-request, together with the proposed Deed of Donation and Acceptance (DDA), was referred to the City Council for appropriate action;

WHEREAS, Section 22(c) of Republic Act (R.A.) No. 7160 otherwise known as the Local Government Code of 1991, empowers the Local Chief Executive to enter into contracts on behalf of the local government unit upon prior authorization by the Sanggunian concerned: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize as it hereby authorizes, the City Mayor, the Honorable Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, representing the City Government of Manila, to sign a Deed of Donation and Acceptance involving one (1) unit mobile laboratory from the Bloomberry Cultural Foundation, Inc. and Bloomberry Resorts and Hotels, Inc., under the "Lab for all" Program of the Office of the First Lady of the Republic of the Philippines; and be it FURTHER
