AN ORDINANCE ABOLISHING FOUR (4) VACANT POSITIONS IN THE STA. ANA HOSPITAL BY WAY OF SCRAP-AND-BUILD TO GIVE WAY TO THE CREATION OF FOUR MORE ESSENTIAL POSITIONS

EXPLANATORY NOTE


Section 325 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, "In cases of abolition of positions and the creation of new ones resulting from the abolition of existing positions in the career service, such abolition or creation shall be made in accordance with pertinent provisions of this code and the civil service law, rules and regulations."

Furthermore, Section 76 of the same act provides that, "Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission (CSC).

To bring the best service to our constituents, the Sta. Ana Hospital, as headed by Officer-In-Charge – Hospital Director Grace H. Padilla, continues to come up with ways to improve their services. One such way is by ensuring that the staffing pattern of the hospital caters to their current needs and that the budget allocated to them is spent wisely.

Sta. Ana Hospital currently has five hundred sixteen (516) plantilla positions. However, upon review and reassessment of the hospital's organizational chart, the institution sees that there is a need to abolish some plantilla items in order to replace it with much more needed ones.

In view of the foregoing, the approval of this Ordinance is earnestly sought.

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Declaration of Policy. – It is hereby declared the policy of the City Government of Manila to faithfully observe the overriding goal of improving the delivery of vital services in terms of quality, scope, speed, accountability, and affordability.

The city and its instrumentalities must promote focused use of limited resources on core functions and programs, while simultaneously cutting and scaling-down, phasing-out or abolishing non-core tasks.

SEC. 2. Abolished Plantilla Positions. – The following positions are hereby abolished in the Sta. Ana Hospital:

SEC. 3. New Plantilla Positions. – The following new plantilla items are hereby created in the Sta. Ana Hospital.

SEC. 4. Qualifications, Powers, and Duties/Responsibilities. – The qualifications, powers, duties and responsibilities of the herein enumerated positions shall be based on the provisions of the Local Government Code, Civil Service Law and other relevant laws.

SEC. 5. – Appointment. – The employment and appointment of the individuals for the herein subject positions shall be in accord with the prescribed qualification standards and guidelines set forth by the Civil Service Commission (CSC) and other relevant agencies.


SEC. 6. Appropriations. – The amount necessary for the creation of four (4) new plantilla positions shall be derived from the available savings generated from the four (4) abolished vacant items in the 2023 Executive Budget. Thereafter, the herein subject new positions shall be automatically funded through the succeeding Annual City Budget as part of the Plantilla Personnel of Sta. Ana Hospital.

SEC. 7. Repealing Clause. – Any provision of ordinances, executive orders, issuances or rules and regulations inconsistent with the provisions of this Ordinance is hereby repealed, amended, or modified accordingly.


SEC. 8. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on May 16, 2024.
