AN ORDINANCE ABOLISHING FOUR (4) VACANT POSITIONS IN THE PARKS DEVELOPMENT OFFICE BY WAY OF SCRAP-AND-BUILD TO GIVE WAY TO THE CREATION OF ONE CHIEF ADMINISTRATIVE OFFICER

EXPLANATORY NOTE


Section 325 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that in cases of abolition of positions and the creation of new ones resulting from the abolition of existing positions in the career service, such abolition or creation shall be made in accordance with pertinent provisions of this code and the civil service laws, rules and regulations.

Furthermore, Section 76 of the same act provides that, "Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission (CSC).

The Parks Development Office (PDO) is responsible for implementing and carrying out development and improvement plans of parks and plazas, tree-planting activities, cleanliness and beautification of center islands and side streets pertaining to socio-environmental services in the City of Manila.

In order to come up with ways to further serve the public in the most effective and efficient manner, the PDO deems it fit to abolish some vacant positions to pave the way for the creation of a Chief Administrative Officer. The PDO sees that such creation would be necessary to be at par with other offices in the City Government and to solidify the functions of the different sections of the office.

In view of the foregoing, the approval of this Ordinance is earnestly sought.

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Declaration of Policy. – It is hereby declared the policy of the City Government of Manila to faithfully observe the overriding goal of improving the delivery of vital services in terms of quality, scope, speed, accountability and affordability.

The city and its instrumentalities must promote focused use of limited resources on core functions and programs, while simultaneously cutting and scaling-down, phasing-out or abolishing non-core tasks.

SEC. 2. Abolished Plantilla Positions. – The following positions are hereby abolished in the Parks Development Office (PDO):

SEC. 3. New Plantilla Position. – The following new plantilla item is hereby created in the Parks Development Office (PDO):

SEC. 4. Qualifications, Powers, and Duties/Responsibilities. – The qualifications, powers, duties and responsibilities of the herein specified position shall be based on the provisions of the Local Government Code, Civil Service Law and other relevant laws.

SEC. 5. – Appointment. – The employment and appointment of the individual for the herein subject position shall be with the prescribed qualification standards and guidelines setforth by the Civil Service Commission (CSC) and other relevant agencies.

SEC. 6. Appropriations. – The amount necessary for the creation of one (1) new plantilla positions shall be derived from the available savings generated from the four (4) abolished vacant items in the 2023 Executive Budget. Thereafter, the herein subject new position shall be automatically funded through the succeeding Annual City Budget as part of the Plantilla Personnel of the Parks Development Office (PDO).


SEC. 7. Repealing Clause. – Any provision of ordinances, executive orders, issuances or rules and regulations inconsistent with the provisions of this Ordinance is hereby repealed, amended, or modified accordingly.

SEC. 8. Effectivity Clause. – This Ordinance shall take effect upon its approval.

This Ordinance was finally enacted by the City Council of Manila on May 16, 2024.




