RESOLUTION COMMEMORATING THE 95TH BIRTH ANNIVERSARY ON MAY 9, 2024 OF THE LATE CONGRESSMAN MARTIN B. ISIDRO WHO REPRESENTED THE FIRST LEGISLATIVE DISTRICT OF THE CITY MANILA

WHEREAS, the Honorable Martin B. Isidro was born on May 1929, graduated with a degree of Bachelor of Laws and passed the Bar Examinations in 1958.

WHEREAS, the former law maker served the Manila 1st District as Member of the House of Representatives during the 8th, 9th and 10th Congress. He also served the Philippine Government in various capacities as Vice-Mayor of the City of Manila from 1972 to 1975, and a 3-Term Councilor;

WHEREAS, the Honorable Isidro also served in the private sector as the President of the Manila Bulletin from 1986 to 1987 and as Corporate Secretary and Compliance Officer of the publishing company from 2006 to 2008. He is also the Senior Vice-President and Corporate Secretary of Philtrust Bank and Manila Hotel from 1998 until his passing;


